- 2 On Monday 15 August 2011 at 10.00 a.m. the Appointed Auditor (A Barrett) at the Council Offices in Ruthin at the request of any local government elector for the area to which the accounts relate, will give the elector or his or her representative, an opportunity to question him about the accounts and any such elector or his or her representative may attend before the Auditor and make objection to any of the accounts. No objection may be made by, or on behalf of, an elector unless the Auditor has previously received written notice of the proposed objection and the grounds on which it was made. Where an elector sends a notice to the Auditor he shall at the same time send a copy of the notice to the County Council at the address shown below.
