Firstly, if the council is investing in creating new gardens and landscaped areas around the town centre, it is essential that funding is also secured for at least one paid horticultural professional to maintain them and coordinate any volunteers.

Rhyl has limited employment opportunities, and if we want people to respect and take pride in the town, it starts by creating jobs that give people purpose and financial security. Expecting people who are already struggling to make ends meet to volunteer indefinitely is simply unrealistic.

Many people assume that anyone can maintain a garden, but horticulture is a science. I studied horticulture myself, and one of the key lessons from my course was how costly it

can be when councils lose specialist knowledge. The council where I studied removed the Parks and Gardens Manager during budget cuts and merged the role under a refuse manager. Without someone with horticultural expertise, planting and pruning are often carried out at the wrong times or in the wrong places, resulting in wasted money and poor-quality public spaces. Investing in professional maintenance from the beginning will protect the council's investment.

My second point concerns the overall upkeep of the town.

There is little point in improving the appearance of Rhyl if the maintenance is not addressed. Rather than relying primarily on enforcement officers to issue fines, I believe the council should invest in highly visible litter pickers who also have the authority to challenge or fine those who litter. Seeing people actively caring for the town encourages others to take pride in it too.

Again, I believe the council should prioritise creating paid employment rather than relying solely on volunteers.

The bins also need improving. As Rhyl is a windy seaside town, open bins allow rubbish to blow back onto the streets. Compactor bins or enclosed bins would help reduce litter significantly.

The streets also suffer from bird fouling and should be cleaned regularly, ideally every evening and morning in busy areas. The growing pigeon and seagull population also needs addressing through humane wildlife management. Bangor University may be interested in carrying out a bird survey or advising on effective management options.

Other towns and cities have reduced bird problems by installing overhead features such as umbrellas, bunting or decorative displays that discourage birds from gathering while also creating attractive streetscapes. Rhyl's seagulls have become particularly aggressive. Around the White Rose Centre they frequently wait for people eating food before swooping down, sometimes striking people on the head. This presents both a nuisance and a safety issue.

I particularly like the proposal for large stone boulder seating, as it is attractive, durable and less prone to vandalism. However, I do not believe the existing benches need replacing.

Before any of this type of work is undertaken you need to take action against those absentee landlords who allow the buildings to fall into disrepair. The clock tower proposal will have no benefit to either the high street or promenade when there are no attractions on the prom. Money needs to be spent on activities and attractions in the vacant area where the sea Life centre was and to have proper plans for using the non-events arena.

RHYL TOWN CENTRE IMPROVEMENTS - Business, Economy and High Street Vitality:

There many proposals in the improvement scheme. But I think the primary proposal should be to reconnect what is essentially a seaside town to its beach. Otherwise you might as well forget it and consign Rhyl to being just another town with little else in its favour. I understand the need for the sea defences of course but it would seem that very little if any thought has been given to restoring Rhyl's status as a seaside town.

You can walk up Rhyl High Street and not know there is a beach nearby and visitors to the town must traverse a barren concrete desert before even catching sight of the sea. There is little to attract people from the town to the beach or from the beach back to the town.

I don't know what's going on in Rhyl - while businesses in surrounding areas are clearly promoted and open for business you can pass by some of Rhyl's attractions and be forgiven for thinking they're closed.

I feel that many of the proposals and some of the things already done are missed opportunities to draw visitors back to Rhyl and support economic regeneration.

What seem to be needed is some imagination:

Make the promenade more like a seaside promenade with lights and bunting in key locations. Set up attractions in the daytime, for example kiosks selling seaside rock, buckets and spades and invite mobile vendors to set up on the promenade to offer ice-creams and coffees. If possible an extra coffee shop for all the dog walkers would be welcome maybe halfway between the Harbour Café and Rhyl Golf club - a café extension to the RNLI building would be ideal as it would bring extra revenue for the RNLI. Make the promenade more attractive for evening walkers - again with additional lighting such as those pretty on the small promenade at Pensarn beach.

Make the funfair more attractive - you can approach the funfair from the beach or the promenade or even the town and not know if the fair is open! Improve lighting on the adjacent buildings to show the fair is open and create a seaside atmosphere.

"Rhyl Beacon" can be seen from around the town and as far afield as Rhos-on-Sea - imagine some people sitting outside a pub at Rhos-on Sea and asking what's that place with the tower? Shall we drive round there for a look tomorrow? Improve the tower lighting; show Rhyl is open for business.

Who is maintaining the Rhyl Clock Tower? Last time I looked 2 of the 4 faces were not working It may seem trivial but when the town clock isn't maintained it gives the impression

the town is run down and that no one cares. And didn't it used to be brightly lit up from the ground?

SC2 - is it open, how can you tell? If you drive by on West Parade you could be forgiven for thinking it is a closed factory outlet. The small pergola entrance to the outdoor pool needs to be painted blue and the glass foyer needs to be lit up. Look at the Nova in Prestatyn or the 1891 at the Pavilion theatre - you can tell when they are open.

Look at Towyn - I can imagine to some passers-by Towyn could look a little tired - but you can certainly tell when it's open and if you visit some of the establishments they have created outside areas that are well lit and decorated with bunting and fabulous hanging baskets and flowers. Compare these outside areas to the pergola at the Queens Market which is simply a sad looking shelter for youths.

Part 2 of 2 ... The Queens Market needs to be rethought - it lacks atmosphere and has suffered anti-social behaviour problems. Again, driving by it can be difficult to know if it is open or closed. The food area has all the appeal of a school canteen and the function areas all the atmosphere of a school disco. How does the food market compare to the Chester Food Market? And whose idea was it to design in two more empty shop fronts at the rear of the hall, that's just what the town needed.

Which brings me to Rhyl's pocket park project - well done, more of that please. Open spaces are preferable to closed and disintegrating shops.

Why was marine drive used as a storage depot when there are there more appropriate areas which could have been used? Marine Drive is a lovely place to walk, why is it being neglected? There are some beautiful cypress trees along a short length of the Drive - additional tree planting would enhance the Drive and help create another asset to Rhyl. there are already some beautiful cypress trees alongside the storage depot - add to these!

Are the same mistakes being repeated? For example - the proposed improved seating in the pedestrian areas, hasn't this been done several times before only to become tired and even vandalised?

Nothing in the proposals shouts Rhyl is open for business and worth visiting. More paving and a few signs will not restore Rhyl's status as a seaside town and improve business.

Easy access to the prom from the top of the high street. At the moment, as I'm a disabled person who rides a scooter, we have to go the long way round which means leaving our family/friends to do so.

## **Ymateb 24**

I would also question the proposal for additional trees along the High Street. The existing trees do not appear to thrive, and more trees may simply encourage larger pigeon populations. Instead, I believe more trees would be better planted along the promenade's grassed areas, where they could provide shade for families enjoying picnics during the summer.

This leads to another suggestion. More picnic benches should be installed, with some incorporating metal plates suitable for disposable barbecues. Clearly marked BBQ disposal bins should also be provided nearby.

These areas could be supported by seasonal food stalls selling picnic food, seafood and refreshments, creating valuable summer employment opportunities.

Regularly visible litter pickers could also act as "Town Sheriffs"—friendly ambassadors who engage with visitors, build relationships with local businesses and residents, monitor the town, and communicate concerns to the police where appropriate.

The Children's Village could also benefit from a water splash play area with interactive fountains similar to those in Piccadilly Gardens, Manchester, or on St Anne's Promenade.

The events arena also has huge untapped potential. It could host local bands, open mic nights, brass bands, community choirs and theatre performances. To generate income, the council could hire out deckchairs and sell refreshments, similar to the successful model used in Scarborough. There are many talented drama groups, musicians and choirs in Rhyl and the surrounding area who would welcome the opportunity to perform.

On quieter days, the arena could also be used for activities such as Segway hire, roller skating, or even a painted children's road safety course where young children can safely learn to ride bikes. Given its proximity to the skate park, these activities would complement the existing facilities perfectly.

Rhyl also needs more reasons for people to visit throughout the year.

The Air Show demonstrated how successful large events can be. Theme markets, comic conventions, Victorian promenade weekends, food festivals, seasonal celebrations and cosplay events would all encourage visitors into the town. These events would also create opportunities for new businesses selling costumes, gifts, food and merchandise.

The council's investment would have far greater long-term value if equal attention is given to maintaining public spaces and creating events that encourage repeat visits.

Another important issue is parking.

Rhyl needs more department stores and free parking. The suggestion of introducing £10 parking charges is, in my opinion, completely counterproductive. It risks discouraging visitors and could seriously impact businesses, including the new cinema, before it has the opportunity to establish itself.

Moving towards Marine Lake, I believe there is also untapped potential.

The lake already attracts visitors, but beyond the miniature railway and crabbing there are few activities available. Paddle boats, rowing boats and small sailing activities would encourage people to stay longer.

The former COVID testing site car park could also provide overnight parking for self-contained motorhomes, bringing additional visitors into the town and supporting local businesses. (I am not referring to parking on the beach near the Pavilion.)

I also remember that a proposal for a surf pool was discussed some years ago. I would be interested to know why this project did not proceed, as it appeared to have significant tourism potential.

Finally, if the council does intend to involve volunteers in maintaining public gardens, I believe the new community centre beside the bowling green would be the ideal base for a Youth Gardening Club. Young people could learn valuable horticultural and environmental skills that would benefit them throughout their lives while also helping to care for their local environment under the guidance of qualified staff.

### **Ymateb 25**

Dont proceed with the project. It will increase anti-social behaviour on the newly paved area up to the Clock Tower. Also make the underground car park free for 3 hours to bring footfall to the High Street. Bring back the Airshow.

Having the ability to close both of these when needed would allow use of the full high street for certain events with notice or something?

Including the upgrade of CCTV and a stopwatch scheme will help reduce trouble in the town.

Encouraging landlords to maintain the facade of properties including above shop levels. A number of buildings have become unsightly with broken windows which allow birds to enter and nest. If landlords do not do this then to use relevant powers and if needed compulsory purchase orders which are used on residential homes.

Encouraging shops to be used - possibly moving tourist information to the town centre as current location is out of the way. If possible to reduce rates/costs for businesses for a certain time to encourage people to come to the town.
