Notice is hereby given that Denbighshire Council intends to vary the rates or fares in accordance with the provisions of section 65 and 66 of the Local Government (Miscellaneous Provisions) Act 1976. The proposals for rates or fares will be as follows: -

Tariff 1

Hirings Between 6 am and 6 pm Monday to Friday:

For the first 7/10th mile - £4.00

Rate for each 1/10th mile or part thereafter – 25p

Waiting time -30p each minute.

Tariff 2

Hirings Between 6 pm and midnight Monday to Friday and 6 am to midnight Saturday and Sunday:

For the first 7/10th mile - £4.80

Rate for each 1/10th mile or part thereafter – 30p

Waiting time - 30p each minute.

Tariff 3

Hirings between midnight and 6 am every day and/or when carrying more than 4 passengers:

For the first 7/10th mile - £5.25

Rate for each 1/10th mile or part thereafter – 37.5p

Waiting time - 40p each minute.

Public and Bank Holidays, Easter Sunday, Christmas Day, Boxing Day and New Year's Day to be charged at Tariff 3 all day. Christmas Eve and New Year's Eve to be charged at Tariff 3 from 6 pm

Luggage (excluding shopping, wheelchairs and pushchairs) outside the passenger compartment – 20p each item.

Carriage of each domestic pet, excluding guide dogs – 20p each pet.

Soiling Charge - £100.00
