Beth yw Gofal Ychwanegol?

Mae tai gofal ychwanegol wedi'u cynllunio i wneud bywyd yn haws i'r rhai a fyddai'n elwa o gael cymorth bob dydd, nad ydynt yn gallu ymdopi â'u sefyllfa byw bresennol. Bydd gennych eich fflat eich hun mewn cynllun tai wedi'u cynllunio'n arbennig, gyda chefnogaeth 24 awr ar gael ar y safle pe byddech ei hangen. Mae tai gofal ychwanegol yn darparu llety mynediad hawdd gydag, er enghraifft, ceginau ac ystafelloedd ymolchi wedi'u haddasu i fodloni eich anghenion unigol. Gallwch ddodrefnu eich fflat yn ôl eich chwaeth eich hun. Bydd gennych gytundeb tenantiaeth / prydles ac yn talu rhent / tâl gwasanaeth i'r gymdeithas tai.

Pam dewis Gofal Ychwanegol?

Bydd Gofal Ychwanegol yn rhoi annibyniaeth o gael eich cartref eich hun gyda'r budd o gael gofal a chymorth personol ar y safle. Gall cyfleusterau gynnwys:

What is Extra Care?

Extra care housing is designed to make life easier for those who would benefit from access to daily support, who cannot cope with their existing living situation. You will have your own flat in a specially designed housing scheme, with 24 hour support available on site should you need it. Extra care housing provides easy access accommodation with, for example, kitchens and bathrooms adapted to meet your individual needs. You can furnish your flat in your own taste. You will have a tenancy/leasehold agreement and pay rent/service charge to the housing association.

Why choose Extra Care?

Extra Care will give you the independence of having your own home with the benefit of on-site personal care and support. Facilities may include:

- Beauty Salon/Hairdressers
- Restaurant
- Communal Lounge area
- Activities/Hobbies room
- Physiotherapy room
- Laundry room

- Ystafell golchi dillad
- Ystafell driniaeth
- Ystafelloedd ymolchi â chymorth
- Ystafell i westai

Oherwydd dyluniad arbennig y fflatiau, lefel y cymorth sydd ar gael a'r ystod o offer y gellir cael gafael atynt, bydd rhai pobl yn gallu aros mewn Gofal Ychwanegol am weddill eu hoes. Fodd bynnag, gall fod amgylchiadau sy'n golygu y byddwch yn gorfod symud i amgylchedd gwahanol i fodloni eich anghenion. Gall hyn fod o ganlyniad i anghenion meddygol, y gellir ond eu bodloni mewn cyfleuster meddygol arbenigol.

Is Extra Care a home for the rest of my life?

Due to the special design of the flats, the level of support available and the range of equipment that can be accessed, some people will be able to remain in Extra Care for the rest of their lives. However there may be circumstances that occur which result in you needing to move into a different environment for your needs to be met. This may be as a result of medical needs, which can only be met in a specialist medical facility.

Where are the Extra Care schemes?

There are schemes based around the county in Rhyl, Prestatyn, Ruthin.

How do I apply?

Applications for the relevant schemes should be made through the housing associations.

A fyddaf yn gymwys?

Yn dilyn yr ymweliad gan y Cynrychiolydd Darparwr Gofal a'r Cynrychiolydd Cymdeithas Tai, os ydych yn bodloni'r meini prawf cymhwyster, bydd gweithiwr gofal cymdeithasol yn gweithio gyda chi i gwblhau cynllun gofal a chymorth. Bydd hyn yn ein helpu i wneud penderfyniad ar ba fath o gymorth sydd ei angen arnoch. Os ydych yn gwpl, gallwch barhau i fod yn gymwys os oes gan un person anghenion cymorth / gofal, lle mae Gofal Ychwanegol yn cael ei asesu fel y ffordd fwyaf effeithiol o fodloni'r anghenion hynny.

A fydd yn rhaid i mi dalu?

Mae byw mewn fflat gofal ychwanegol yr un fath â byw mewn unrhyw eiddo ar rent neu eiddo sy'n berchen i rywun arall. Byddwch yn gyfrifol am dalu rhent a biliau eraill y cartref, er byddai unrhyw Fudd-daliadau y mae gennych hawl iddynt yn dal i'ch cefnogi i wneud hyn. Bydd angen i chi hefyd dalu am unrhyw gynllun gofal a chymorth ar ôl asesu eich bod eu hangen, ond bydd hyn yn seiliedig ar asesiad o'ch gallu i dalu a bydd yn cael ei gapio ar yr uchafswm a ganiateir gan Lywodraeth Cymru, sydd ar hyn o bryd yn £60 yr wythnos.

Will I qualify?

Following the visit by the Care Provider Representative and Housing Association Representative, if you meet the eligibility criteria a social care worker will work with you to complete a care and support plan. This will help us to make a decision on what kind of support you need. If you are a couple, you can still qualify if one person has care/support needs where Extra Care is assessed as the most effective way of meeting those needs.

Will I have to pay?

Living in an extra care apartment is the same as living in any other rented or owned property. You will be responsible for paying rent and other household bills, although any Benefits you are entitled to would still support you in doing this. You will also need to pay for any care and support plan that you are assessed as needing, but this will be based on an assessment of your ability to pay and will be capped at the maximum allowed by Welsh Government, currently £60 per week.
