### Other Fees

- Right to erect a Memorial: £120.00
- Memorial when Temp Cross Fee has been paid (Please ring cemeteries office to confirm as some crosses have been placed with no permits): £75.00
- Right to erect a tablet/book: £120.00
- Additional inscription: £45.00
- Vases: £45.00
- Temporary Wooden Cross (No fee is due if the cross is replacing a headstone on a reopened grave for a temporary period): £45.00
- Search of records family history: £35.00

All burial fees are doubled if the deceased was not a resident of Denbighshire at the time of death unless the deceased had been living outside Denbighshire for less than 2 years before their death for healthcare or social care purposes.
