# **Modification of Definitive Map**

# Description of path to be added

A public footpath commencing from a point (marked A on the Order Plan) on the A547 Ffordd Talargoch starting at SJ 05892 80662 and running in a south easterly direction for 42.8 metres to a point at SJ 05924 80663 (marked point B on the Order Plan) and then continuing in a generally south easterly direction for 59.2 metres to a point at SJ 05965 80592 (marked C on the Order Plan) where it joins with existing public footpath 19 marked on the Order Plan.

**Width**: The path is approximately 3 metres wide with a mixed grass and earth surface at all points marked on the Order Plan.

Limitations: The gate at SJ 05294 80663 which is marked point B on the Order Plan.
