

# Denbighshire County Council (Off-street parking places) (consolidation) order 2021 Variation St. Peter's Square car park Ruthin Order 2026

Denbighshire County Council (hereinafter called "the Council") in exercise of its powers under Sections 32, 33, 35(1), 35(3) and 35A and 35B and 124 (1) and Part III of Schedule 9 of the Road Traffic Regulation Act 1984, as amended ("the 1984 Act"): and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

- 1. This Order shall come into operation on the day of 2026 and may be cited as the Denbighshire County Council (Off-Street Parking Places) Consolidation Order 2021 variation St. Peter's Square Car Park Ruthin Order 2026
- 2. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment provided that where a prohibition or restriction which is imposed, varied or revoked by this Order is in conflict with a prohibition or restriction imposed by a previous Order, then the provision of this Order shall prevail.
- 4. If a court, the Welsh Government or The Traffic Penalty Tribunal, declares any part of this Order to be invalid or un-enforceable, such declaration shall not invalidate the remainder of the Order.
- 5. Denbighshire County Council (Off-Street Parking Places) Consolidation Order 2021 (hereinafter referred to as the "Principal Order") is hereby varied as follows:



- 6. The car park specified in Schedule 1 to this Order is deleted from the Principal Order and replaced by the car park annexed and signed as relative to this Order as specified in Schedules 3 and 4 to this Order which are substituted therefor and hereby added and incorporated into schedules 1 and 2 to the Principal Order;
- 7. The car park plan specified in Schedule 2 to this Order is deleted from the Principal Order and replaced by the car park plan annexed and signed as relative to this Order as specified in Schedule 5 to this Order which is substituted therefor and hereby added and incorporated into schedule 4 to the Principal Order;
- 8. The area of land specified as shown on the plan in Schedule 5 to this Order and listed in Schedules 3 and 4 to this Order may be used, subject to the provisions of this Order, as a place to park vehicles of such classes, in such positions, on such days, during such hours, for such period and on payment of such charges as are advertised at each parking place and as are specified in the Schedules 3 and 4 to this Order (as varied from time to time).
