

Denbighshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2021 Variation (Various Roads Ruthin) Order 2026

Denbighshire County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 4, 25, 32, 35,36, 45, 46,46A, 47, 49, 51, 52 and 53 and 124(1) of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers and after consultation with the Chief Constable of North Wales Police and in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

- This Order shall come into operation on the __/__/2026 and may be cited as
 "Denbighshire County Council (Prohibition and Restriction of Waiting and Loading
 and Parking Places) (Consolidation) Order 2021 Variation Various Roads Ruthin
 Order 2026.
- 2. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament and as if for the purposes of Section 21 of that Act this Order were an Act of Parliament and the Orders revoked by this Order were Acts of Parliament thereby repealed.
- 3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment provided that where a prohibition or restriction which is imposed, varied or revoked by this Order is in conflict with a prohibition or restriction imposed by a previous Order, then the provision of this Order shall prevail.
- 4. If a court, the Welsh Government or The Traffic Penalty Tribunal, declares any part of this Order to be invalid or un-enforceable, such declaration shall not invalidate the remainder of the Order.



- 5. Denbighshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2021 (hereinafter referred to as the "Principal Order") is hereby varied as follows:
 - (ii) the plans specified in Schedule 1 to this Order are deleted from the Principal Order and the plans annexed and signed as relative to this Order and listed in Schedule 2 to this Order are substituted therefor and hereby added and incorporated into schedules 1 and 2 to the Principal Order;
