

Denbighshire County Council (Various Roads Ruthin) (ONE-WAY TRAFFIC) Order 2026

Denbighshire County Council in exercise of its powers under Sections 1,2 and 4 and Part III of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers and after consultation with the Chief Constable of North Wales Police and in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

- In this Order except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 2. (a) No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to proceed along the lengths of roads specified in Schedule 1 to this Order other than in the direction stated in the said schedules
 - (b) Nothing in Article 2(a) of this Order shall apply so as to prevent any person from causing any pedal cycle to proceed in that section of the road specified in Schedule 2 in either direction.

3. General Exemptions

Nothing in Article 2 of this Order shall render it unlawful to cause or permit any vehicle to travel in a direction other than the ones set out in this order, for so long as may be necessary to enable: -

- (a) The vehicle to be used by the emergency services in pursuance of statutory powers or duties.
- (b) The vehicle to be used for the purposes of the local authority in pursuance of statutory powers or duties if it cannot be conveniently used for such purpose in any other road
- (c) The vehicle if it cannot be conveniently used for such purpose in any other road to be used in connection with any of the following: -

- (ii) Building, industrial or demolition work
- (iii) The removal of any obstruction to traffic
- (iv) The maintenance, improvement, or reconstruction of the said lengths of roads
- (v) The laying, erection, alteration, or repair in or in land adjacent to the said lengths of roads of any sewer or of any utility apparatus or the exercise of any other statutory power or duty for the maintenance and supply of gas, water, electricity or of any telecommunications system as defined in Section 4 of the Telecommunications Act 1984.
- 4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment provided that where a prohibition or restriction which is imposed, varied, or revoked by this Order is in conflict with a prohibition or restriction imposed by a previous Order, then the provision of this Order shall prevail.
- 5. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 6. This Order shall come into operation on the __/__/2026 and may be cited as "Denbighshire County Council (Various Roads Ruthin) (One Way Traffic) Order 2026.
- 7. If a court, the Welsh Government or The Traffic Penalty Tribunal, declares any part of this Order to be invalid or un-enforceable, such declaration shall not invalidate the remainder of the Order.
 - 8. The County of Denbigh (St. Peter's Square, Ruthin (One Way Traffic) Order 1969 is hereby revoked:

One-Way Traffic

Moving Traffic Restrictions

Street Name: Well Street

Permitted Direction: Northerly

Descriptions: From its junction with Record Street to its junction with Market Street

Street Name: Market Street

Permitted Direction: North Easterly

Descriptions: From its junction with Well Street to a point 12m South of its junction with

Wynnstay Road

Street Name: St. Peter's Square

Permitted Direction: Clockwise Direction- northerly, easterly and southerly

Descriptions: That length of road which surrounds St Peter's Square, Ruthin on its westerly, northerly and easterly sides from its junction with Clwyd Street clockwise to its junction with

Market Street

Schedule 2

One-Way Traffic (two-way exemption for pedal cycles)

Street Name: Market Street

Permitted Direction: South Westerly

Descriptions: From a point 12m South of its junction with Wynnstay Road to its junction with

Well Street.
